

ENTRIES & FEES

All applications must be received by **September 26th at 5:00pm**. Entries may also be dropped off at The Country Club at WoodCreek Farms and provided to Bruce Rienecker. No telephone entries will be accepted. As in previous years, **NO TIME CONSIDERATIONS WILL BE GIVEN!**

Starting times will be available on Monday September 29th after 5pm. Players should go to www.benefit-tournament.com for starting times. Players must be available at all times, and everyone is responsible for finding out their starting times. Players may contact Bob Avery at (803) 269-3616 if they have a problem locating their starting times.

All players should report twenty (20) minutes prior to their match time to check-in and receive court assignments.

Play will begin on Thursday October 2nd for larger draws. For matches on Thursday and Friday, play will begin at 6:00pm.

A consolation round will be offered for all first match losers. The consolation rounds will begin on Saturday morning. In lieu of a third set, a tiebreaker will be used to determine a match tied at one set all. **Alternate sites may be used if necessary.**

AWARDS

Awards will be given to the finalists and champions of each division that has at least eight teams competing. Divisions that have less than eight teams, awards will only be given to the champions.

All participants will receive a tournament gift. There will be complimentary soda, water, and fruit all weekend for players. - Hard courts and clay courts will be used as necessary.
- All matches will be best two-out-of-three sets and the seven point tiebreaker will be used in all sets that reach a score of 6 – 6.
- If you do not send in seeding information, you do not have the right to challenge your position in the draw.
- In case of inclement weather, a no-ad scoring system may be implemented.
- Proceeds from the tournament will benefit the South Carolina Free Medical Clinic.
